1. THE LESSEE PROMISES AND AGREES TO RETURN SAID VEHICLE (S) IMMEDIATELY FOLLOWING THE COMPLETION OF THE RENTAL TERM IN GOOD CONDITION AND AGREES TO PAY ANY DAMAGES THAT ARE SUSTAINED TO SAID EQUIPMENT OTHER THAN NORMAL WEAR. ANY DEPOSIT PURSUANT TO THIS AGREEMENT MAY BE UTILIZED BY THE LESSOR TO SATISFY ANY DAMAGE TO THE CAR (S) WHILE IN POSSESSION OF THE LESSEE.
2. ANY DAMAGE TO THE RENTAL VEHICLE (S) MUST BE REPORTED IN WRITING TO THE LESSOR UPON DISCOVERY. THE LESSEE IS RESPONSIBLE FOR THE COST OF REPAIRS OR CLAIMS RESULTING FROM SUCH DAMAGE. DAMAGED VEHICLE (S) MUST BE WITHDRAWN FROM SERVICE IMMEDIATELY.
3. THE LESSEE AGREES TO PAY ANY DAMAGES, EXPENSES, CLAIMS, FEES, OR TARIFFS OF ANY NATURE WHATSOEVER THAT MAY ARISE FROM OR THROUGH THE LESSEE'S USE OF SAID VEHICLE (S), NEGLIGENT OR OTHERWISE.
4. THE LESSEE AGREES TO HOLD SATCH SALES, INC. OR ANY OF IT'S AGENTS FREE AND HARMLESS FROM ANY DAMAGES, EXPENSES, CLAIMS, FEES, OR TARIFFS OF ANY NATURE WHATSOEVER THAT MAY ARISE FROM OR THROUGH THE LESSEE'S USE OF SAID VEHICLE (S), NEGLIGENT OR OTHERWISE.
5. LESSEE ASSUMES RESPONSIBILITY FOR SECURITY OF THE VEHICLE (S) AND FOR MAINTAINING ADEQUATE INSURANCE (FIRE, THEFT, COLLISION, PUBLIC LIABILITY) ON THE VEHICLE (S) FROM DELIVERY TO PICKUP. LESSEE AGREES TO NAME LESSOR AS ADDITIONAL INSURED.
6. LESSEE MUST REMOVE ALL DEBRIS, TRASH, GARBAGE, ETC. FROM THE VEHICLE (S) PRIOR TO PICKUP OR BE ASSESSED A \$25.00 PER UNIT CLEANING FEE.
7. LESSEE REPRESENTS THAT HE IS FAMILIAR WITH THE OPERATION AND USE OF SAID VEHICLE (S) AND THAT LESSEE CAN OPERATE AND CONTROL SAME. MUST BE OF DRIVING AGE TO OPERATE VEHICLE.
8. THE LESSEE AGREES TO PERFORM SUCH DUTIES AS CHARGING OR FUELING THE CARS, MAINTAINING THE BATTERIES, AND REPAIRING FLAT TIRES.
9. LESSOR SHALL RETAIN TITLE TO SAID VEHICLE (S) AT ALL TIMES. SAID VEHICLE (S) MAY NOT BE REMOVED FROM THE ABOVE MENTIONED LOCATION.
10. THE LESSEE SHALL USE THE VEHICLE (S) EXCLUSIVELY FOR THE ABOVE PURPOSE (S).
11. LESSOR HAS THE RIGHT TO WITHDRAW CARS AT ANY TIME FOR MAINTENANCE PURPOSES AND LESSOR WILL FURNISH A REPLACEMENT. FURTHERMORE, LESSOR HAS THE RIGHT TO WITHDRAW CARS FOR ANY DEFAULT OF THE LESSEE INCLUDING NON-PAYMENT, INSOLVENCY, OR BANKRUPTCY, WHEREUPON THE LESSOR CAN ENTER THE PREMISES OF THE LESSEE TO TAKE POSSESSION. THE LESSEE SHALL NOT BE RELIEVED OF LIABILITY FOR PAST DUE PAYMENTS IN THE EVENT OF SUCH WITHDRAWAL.
